TOAC members met for exploring the avenues for improvement in the university and suggested the following.

TOAC appreciates the effort of the NIRF team members who have placed the university at "—"th rank at National level.

- * It is suggested that UGC/MHRD has recommended many criteria for research programs conducted by the Universities. In this regard, to include the criteria, the M.Phil/Ph.D. regulations of our university need to be modified which will improve the quality of research.
- * It is recommended that with the expansion of affiliating colleges under this university and expansion in many other activities pertaining to SDE the space of examination needs to be improved. Construction of a separate building to hold all the examination activities within that would make the process easier and more confidential.
- * It is suggested that university encompassing vast working area and residential area is utilizing enormous electricity. Finding an alternate resource such as solar energy/power to meet the needs would lessen the expenditure and also university can become self sufficient.

- * It is suggested that the establishment of new departments in a way has improved the university status but for those departments, infrastructure facilities need to be provided. The newly established departments shall be provided with enough space for their growth and construction of new building to suit their needs would be an ideal solution.
- * It is suggested that, steps need to be taken to increase the number of extramural projects.
- * It is recommended to conduct Academic audit for this year in the month of August to consider and approve the Annual Quality Assurance Report (AQAR) for the academic years 2015-2016 which are to be submitted to NAAC based on the quality parameters.

- * M.Phil / Ph.D. regulations of our University modified to improve the quality of research.
- * Efforts taken for SDF the space of examination to be improved.
- * Solar energy / power has been established
- * Recommended for newly established departments to be provided with enough space.
- * Faculty and students are encouraged to apply for various funding agencies.
