1. Open Tenders consist of Tender conditions Technical Bid and Financial Bid and will be received by the Director, upto 3.00 p.m. on 04-02-2022 for the Purchase of PowerEdge R750 Server in the School of Distance Education, Bharathiar University, Coimbatore as given in the schedule.
2. Technical Bid and Financial Bid shall be submitted in separate sealed covers each superscribed as "Technical Bid for Tender for Purchase of PowerEdge R750 Server" and "Financial Bid for Tender for Purchase of PowerEdge R750 Server". The above said two bids together with signed copy of the tender conditions shall be enclosed in another cover superscribed as "Tender for Purchase of PowerEdge R750 Server" to the School of Distance Education due on 04-02-2022 by 3.00 p.m.
3. The tender Technical Bid and Financial Bid will be opened by the Director in the Director's Chamber on the same day on 04-02-2022 at 4.00 p.m. in the presence of tenderers who are present.
4. Each tender shall be accompanied by EMD amount for a total of Rs.23,000/- in the form of Demand Draft drawn on Nationalized Bank in favour of the Director, Bharathiar University, payable at Coimbatore. Tenders without EMD shall be summarily rejected. EMD will not carried interest.
5. The tender cost of Rs.6,300/- in the form of Demand Draft drawn on Nationalized Bank in favour of the Director, Bharathiar University, payable at Coimbatore. Tenders without Tender Cost shall be summarily rejected. EMD will not carried interest.
6. Tenders received late will be returned to the Tenderer unopened.
7. The tenderer should quote his rate in figures and words in the prescribed tender schedule only. Corrections or overwriting if any shall be attested with the full signature of the Tenderer.
8. The Tenderer should sign on each page of the tender document.
9. The price quoted shall be inclusive of GST or any other charges
10. Tender documents are not transferable.
11. The tender shall be submitted only in this official form and the tenderers should sign on each page of all the tender documents and enclosed without any omission.
12. The tender shall be valid for a period of 90 days from the date of opening. Tenderer should not withdraw his tender after the tenders are opened. In case the tender is withdrawn after it is opened, the EMD will be forfeited.

Security Deposit will be refunded after the audit.
16. The material should be supplied within the stipulated period mentioned in the supply order. If the supply is not made within the period the supply order will be cancelled and the EMD will be forfeited.
17. Any dispute arising out of this contract shall be settled only in the court having jurisdiction of Coimbatore.
