Statue 1. _ It shall be competent for the Syndicate to appoint a Legal Advisor/ Standing Counsel for the University for such period on such terms as it *may decide* to perform such duties as it may fix from time or time. Statute 2._ The Legal Advisor /

Statute 2. _ The Legal Advisor/Standing Counsel so appointed shall not be a member of any of the authorities of the University.
